PREPLANT: Broadcast 7 ½ lbs. per 1,000 sq. ft. (325 lbs. per acre).

GROUNDCOVER: Broadcast at 3 lbs. per 500 sq. ft. (20' x 25') of planting area. SHRUBS & EVERGREENS: Sprinkle ¼ cup evenly around dripline of plant and work into top 1 inch of soil.

TREES: Apply ½ lb. per 1 inch of trunk diameter. Distribute evenly under branches out to dripline.

NOTE: Liquid measuring cups are very close in estimating the weight of dry granular fertilizers. Example: an 8 oz. (1 cup) measuring cup holds approximately 8 oz. (1/2 lb.) of dry granular fertilizer.
