

AQUASPHERE® IRRIGATION

Biodegradable, time-release dispenser that is designed to improve water quality in lakes and ponds

Specially formulated to compensate for the turnover of water in irrigation ponds

AQUASPHERE® IRRIGATION is designed to prevent poor water clarity, odor and floating or suspended organic matter by consuming the excess nutrients in the water for improved water quality and clarity in irrigation lakes and ponds. AQUASPHERE® IRRIGATION contains a proprietary blend of naturally occurring bacteria and enzymes that reduce the organic debris that collect in water. There is no need to remove the sphere after 30 days because the outer shell of AQUASPHERE® IRRIGATION is made of a corn starch-based material and will completely degrade / compost within your pond over time.

WHAT TO EXPECT FROM AQUASPHERE® IRRIGATION

Correcting water problems naturally occurs with time and continued use. This product is safe for fish, animals, wildlife, people, and plants. Every body of water is different, therefore results may vary. Some ponds will react more quickly than others due to their specific water conditions. The key to improved water quality is the monthly application of the all-natural bacteria and enzymes that are included in the patented, time-released AQUASPHERE® IRRIGATION. With continued use, you can expect improved water quality and clarity while eliminating odors.

CALCULATE THE NUMBER OF SPHERES NEEDED

Calculate the total gallons in the pond or area to be treated:

(Length x Width x Average Depth x 7.5 = Total Gallons)

Do not under treat water! Over treating is safe for all fish and animals, and will yield optimal results. If your pond exceeds the number gallons specified on the label (e.g. 500,000 gallons), use multiple spheres per 30 day period.

WATERPACK® PROGRAM

For difficult-to-treat ponds and lakes, NATURAL BLAST®, RUSH® and colorants (e.g. SABLE BLACK® and TAHOE BLUE®) should be used in conjunction with AQUASPHERE® IRRIGATION for optimum results. To learn more visit us online at www.th.simplot.com.

NOTE: This is an all-natural system. It may require 4-6 weeks to achieve water quality improvement. For best results do not use chemicals in pond.

DIRECTIONS FOR USE

Use in self-contained ponds and retention areas.

1. Keep AQUASPHERE® IRRIGATION dry until pond application.
2. Remove outer plastic bag and gently toss all contents into the ponds. DO NOT OPEN THE SPHERE. The inner bags are water soluble and will dissolve upon contact with water.
3. Deploy accurate number of sphere(s) every 30 days.
4. Sphere placement: Evenly deploy sphere throughout the pond, if possible 10 feet from shoreline.
5. AQUASPHERE® IRRIGATION works very well with all types of aeration. Whenever possible avoid placing spheres in close proximity to aerators.
6. The sphere will sink to the bottom of the pond after 30 seconds of being deployed and begin to work instantly.
7. Treat when water temperatures are between 45 °F - 110 °F.

The entire shell and all inner contents will compost in your pond over time. It is not necessary to remove the marine degradable sphere after the 30 days.

For season-long care, follow up with AQUASPHERE® IRRIGATION every 30 days while water temperatures are between 45°F - 110°F.
