Greens, Tees, Fairways, and Other Turf	Apply 1-2 fl oz / 1,000 ft <sup>2</sup> (30-60 mL/93 m <sup>2</sup> )	Apply every 14-21 days or as needed. More frequent applications may be necessary during periods of rapid growth.

Use sufficient water for good coverage (1 – 2 gallons / 1000 ft<sup>2</sup> or 45 – 90 gallons / acre). For best results, apply before 10:00 A.M. or after 4:00 P.M. The use of a non-ionic surfactant (e.g. SPRAY-WET<sup>®</sup>) is recommended for uniform coverage. Note: To avoid staining, do not apply GRID IRON<sup>®</sup> 7-0-1 to non-target surfaces (sidewalks, fences, etc.).

Trees, Shrubs, & Herbaceous Plants	Mix 64 fl. oz (2 L) of GRID IRON <sup>®</sup> 7-0-1 in 100 gallons (375 L) of water and apply 5 gallons (20 L) of mix per inch (2.5 cm) of trunk diameter at breast height. Tank mix should be injected in a circular grid pattern starting 1 ft (30 cm) from trunk and continuing 2 ft (60 cm) past the drip line.
Ornamentals	Mix 3 fl oz (90 mL) of GRID IRON <sup>®</sup> 7-0-1 in 4 gallons (15 L) of water and spray to runoff.

Apply as a foliar, drench or during transplant based on the rates and dilutions listed above. Do not apply to flower buds or blossoms of flowers, shrubs, and trees. For optimum results of foliar applications on plants with waxy leaf surfaces, adding 12 fl. oz. of a non-ionic surfactant (e.g. SPRAY-WET\* 90% NIS) per 100 gallons (0.10% v/v) of finished spray solution will aid in leaf coverage and penetration.
