SPRAY-MIX® can be used to either prevent or correct most incompatible tank

USE RATES

Application

Per 100 gals of spray solution

Prevent antagonistic tank mixing conditions

1 - 4 pints

Correct tank mix incompatibilities 3 - 6 pints

MIXING: In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

- 1. Compatibility agent and/or antifoam, if needed
- 2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
- 3. Dry soluble and suspension fertilizers / micronutrients
- 4. Liquid drift retardants and flowable formulations (F & FL)
- 5. Liquid concentrates, suspension and microencapsulated (LC, SC, ME)
- 6. Emulsifiable concentrates (E, EL or EC)
- 7. Solutions and soluble liquids (S or SL)
- 8. Liquid micronutrients and fertilizers
- 9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
- 10. Finish filling to desired spray volume level and continue agitation
