SHRUBS & EVERGREENS: Sprinkle ½ cup evenly around dripline of plant and work into top 1 inch of soil. TREES: Apply 1/2 lb. per 1 inch of trunk diameter. Distribute evenly under branches out to dripline.

GROUNDCOVER: Broadcast at 3.8 lbs. per 1000 sq. ft. (20' x 50') of planting area.


