**PREPLANT:** Broadcast 5.9 lb per 1,000 sq. ft. (256 lb per acre).

**GROUND COVER:** Broadcast at 3.3 lb per 1,000 sq. ft. (1/3 lb per 100 sq. ft.).

**SHRUBS & EVERGREENS:** Sprinkle 1/4 cup evenly around dripline of plant and work into top 1 inch of soil.

**TREES:** Apply 1/3 lb per 1 inch of trunk diameter. Distribute evenly under branches out to dripline.

**NOTE:** Liquid measuring cups are very close in estimating the weight of dry granular fertilizers. Example: an 8 oz. (1 cup) measuring cup holds approximately 8 oz. (1/2 lb) of dry granular fertilizer.

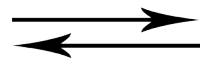
