CITRUS & AVOCADO TREES: Make 3 applications per year (Feb - March, June - July, Oct - Nov).

Mature Trees: Apply 6 lb around the dripline of the tree.

Younger Trees: | 4-6 ft high: 8 oz | 2-4 ft high: 2 oz | Newly planted: 1 tbsp |

NOTE: Liquid measuring cups are very close in estimating the weight of dry fertilizers. E.g. An 8 oz (1 cup) measuring cup holds approximately 8 oz (0.5 lb) of dry fertilizers.
