	<b>Normal Water Repellency Conditions</b>	3-6 Fl. Oz.	2 Gal of Water	90-180 mL
	Apply Rely III™ every 14-28 days. For best results, begin applications at least one month prior to the normal onset of water repellency conditions. Irrigate sufficiently to remove Rely III™ from leaf tissue. Do not apply to turf under stress.			
<b>High Water Repellency Conditions</b>	6 Fl. Oz. (high) 3 Fl. Oz. (low)	2 Gal of Water	180 mL (high) 90 mL (low)	8 L of Water
	Apply Rely III™ every 14-28 days at the high rate until repellency conditions subside. Adjust accordingly to conditions.			
<b>Seeding</b>	4 Fl. Oz.	2 Gal of Water	130 mL	8 L of Water
	Apply Rely III™ at above rates two (2) week prior to seeding. Irrigate sufficiently to remove from leaf tissue.			
<b>Sodding</b>	4-6 Fl. Oz.	2 Gal of Water	130 - 180 mL	8 L of Water
	Apply Rely III™ at above rates to newly laid sod. Irrigate well to distribute Rely III™ throughout the rootzone, and to remove from leaf tissue
