#### Cool Season Turf (Greens & Tees):

Apply 4-6 oz. per 1,000 ft<sup>2</sup> (0.10 - 0.16 lb K<sub>2</sub>O per 1,000 ft<sup>2</sup>) as necessary. Dilute with 0.5 to 2 gallons of water per 1,000 ft<sup>2</sup> and apply every 7-14 days or as needed.

#### Warm Season Turf (Greens & Tees):

Apply 4-8 oz. per 1,000 ft<sup>2</sup> (0.10 - 0.20 lb of K<sub>2</sub>O per 1,000 ft<sup>2</sup>) as necessary. Dilute with a 0.5 to 2 gallons of water per 1,000 ft<sup>2</sup> and apply every 7-14 days or as needed.

### Nursery & Ornamentals (Foliar/Drench/Transplant):

Apply 4-6 quarts per 100 gallons.
